NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$ 0.0042 per \$100 valuation has been proposed by the governing body of High Plains Underground Water Conservation District No. 1 (HPWD)

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for HPWD from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval tax rate is the highest tax rate that HPWD may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that HPWD is not proposing to increase property taxes for the 2023 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 12, 2023 at 1:30 PM at 2930 Ave. Q, Lubbock, TX 79411.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, HPWD is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the HPWD of HPWD at their offices or by attending the public meeting mentioned above.
